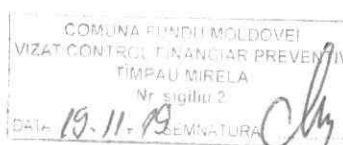
Art.2. Primarul comunei și compartimentul financiar – contabil vor aduce la îndeplinire prevederile prezentei hotărâri.
